- II. ENTERPRISE CAMPUS AUTHORITY MINUTES

Tyger River Campus
Total Operating Expenses = \$211,729 which is 19% of the total budget. This includes Operating Expenses and Payroll Expenses.

Cherokee County Campus
Total Operating Expenses = \$239,729 which is 22% of the total budget. This includes Operating Expenses and Payroll Expenses.

Downtown Campus

Total Operating Expenses = \$138,530, which is 24% of the total budget. This includes Operating Expenses and Payroll Expenses.
