# **OVERVIEW OF CAMPUS POLICE:**

Campus Police officers are appointed and commissioned as State Constables by the Governor of South Carolina as provided by Title 23, Chapter 1, Article 60, Code of Laws of South Carolina, 1976, as amended. As such, they are empowered to enforce the laws of South Carolina. Campus Police officers have complete police authority to apprehend and arrest anyone involved in illegal acts on campus and in areas immediately adjacent to the campus.

If a college student commits minor offenses involving college rules and regulations, Campus Police may also refer the individual to the Dean of Student Engagement for follow-up and determination of disciplinary proceedings and actions. The Dean of Student Engagement has been designated by the Vice President for Student and Community Advancement to oversee student discipline, grievances, and student judicial processes in accordance with the college's Student Code and Grievance Procedure. The college also employs security officers to assist Campus Police in patrolling the campuses.

These security employees also help with routine security matters such as unlocking or locking doors and enforcing the college's parking policy. The Campus Police Department can request assistance from local and state law enforcement agencies for major offenses such as rape, murder, aggravated assault, robbery, and auto theft. These cases can be investigated jointly by the Campus Police and the local or state law enforcement agencies to solve these serious felony crimes. Prosecuting all criminal offenses, both felony and misdemeanor, are conducted at local courts with jurisdiction. Campus Police personnel work closely with local, state, and federal police agencies and communicate directly with local law enforcement agencies on the police radio network.

Campus Police and local authorities communicate regularly on the scene of incidents that occur in and around the campus area. Campus Police work closely with local agencies' investigative staff when incidents require joint investigative efforts, resources, crime-related reports, and information exchanges, as deemed necessary. However, by mutual agreement with state and federal agencies, Campus Police have access to communications through NLETS (National Law Enforcement Telecommunications System).

Through this system, police personnel can access the National Crime Information Center and the South Carolina Information Enforcement System. These computer databases are used for accessing criminal history data, nationwide police records, driver/vehicle identification information, and other local, state, and federal law enforcement information. Through coordination with local law enforcement agencies, reports from any criminal activity engaged in by students off-campus may be provided to the Director of Student Affairs for any action or follow-up that may be required.

# **CRIME PREVENTION AND REPORTING PROCEDURES:**

#### **CRIME PREVENTION**

Crimes can occur at Spartanburg Community College just as they can occur anywhere. Preventing them is a shared responsibility of the entire college community. If you are a victim or witness or have knowledge of a crime, you should immediately report the crime or suspicious activity to Campus Police at 864-592-4911 or in an emergency, dial #911. Please DO NOT assume someone else has reported the incident. The Department of Campus Police provides awareness and crime prevention training periodically throughout the year. Information on these programs and basic crime prevention and safety tips are available on the Campus Police website. A common theme of all awareness and crime prevention training is to encourage students and employees to be aware of their responsibility for their own security and the security of others. In addition to training sessions, information on this topic is disseminated to students and employees through various means, including literature, displays, and the college's electronic mail system.

#### **CRIMINAL ACTIVITY OFF-CAMPUS**

The college does not have any officially recognized student organizations with offcampus locations. However, college student organizations sometimes attend offcampus events in locations in the nearby community, other areas in the state, and outof-state. Student organizations follow designated procedures for travel and are supervised by a college advisor who is a faculty or staff member of the college. Students must abide by the same protocol and the same Student Code policy at offcampus events that they do when attending on-campus activities. Infractions of the Spartanburg Community College Student Code are reported to SCC Police Department for inclusion in crime statistics, as appropriate, and to the Dean of Student Engagement for follow-up and disciplinary actions, as needed. If a violation of law occurs at an offcampus event, the advisor will immediately inform SCC Police Department and the Dean of Student Engagement and involve local law enforcement officials at the site where the infraction occurred.

#### ALCOHOL AND DRUGS

#### **Alcoholic Beverages**

Spartanburg Community College is concerned about the abuse of alcohol and the use of illegal drugs on all campuses. The college is in compliance with the Drug-Free Schools Act of 1989 and has established policies and programs in support of this

legislation, as noted below. In addition, the Student Code of Spartanburg Community College and college personnel policies support college policy. This information is outlined in the Spartanburg Community College Student Handbook, located online at <a href="https://catalog.sccsc.edu/index.php?catoid=22">https://catalog.sccsc.edu/index.php?catoid=22</a> and in Spartanburg Community College employee materials and college procedures. An alcohol and drug education and counseling program for students is offered through the Department of Counseling and Career Services, and for SCC employees, it is offered through the Employee Assistance Program.

The possession, sale, dispensing, and/or the use of alcoholic beverages shall not be permitted on the college premises except by persons of legal age at college-sponsored events for adult community or business groups with prior presidential approval. The possession, sale, use, and/or dispensing of alcoholic beverages shall be in compliance with the laws of South Carolina and will be strictly enforced, including the underage drinking laws.

"College" is defined to include the location of any off-campus facilities under college control for purposes of student educational uses. Such definition shall not apply to non-educational activities such as social events, planning meetings, conferences, training sessions, or other functions held off campus, subject to the specified limitations. In the event alcoholic beverages are made available at off-campus locations where student and/or faculty/staff non-educational functions are held, such alcoholic beverages shall normally be dispensed by retail establishments (vendors) licensed by the state. The vendor shall assume all responsibility for compliance with age requirements and other criteria established by statute, case law, common law, or other legal standards. In special cases, the President may approve other than licensed vendors when there is no such licensed vendor associated with the location at which the event is held. In these cases, the dispensing of alcoholic beverages shall be in compliance with the laws of South Carolina.

#### Illegal Drug Possession

All Spartanburg Community College Campuses have been designated "Drug-free." The possession, sale, manufacture, distribution, and/or the use of drugs – except those which can be acquired legally over the counter and those prescribed for a specific individual's use by a licensed physician or dentist – shall not be allowed on the premises of the college, and federal and state laws pertaining to these drugs shall be strictly enforced. Additionally, any misuse of the excepted drugs (prescribed or over the counter) shall not be permitted. Violators are subject to college disciplinary action, criminal prosecution, fines, and imprisonment.

The following information is provided on the college's website, under consumer information, and students and employees are informed of this information during their orientation to the college:

• The college's Alcohol and Drug Policy

• The Alcohol and Drug Policy of the South Carolina Technical College System (which includes harmful effects of drugs by type)

- South Carolina Drug Laws
- Alcohol Effects and Health Risks
- Federal Illegal Possession Penalties-Controlled Substances
- Alcohol and Drug Support Resources for Counseling and Intervention

Spartanburg Community College supports strict enforcement of laws concerning the possession, consumption, or distribution of controlled substances, as set forth in the South Carolina Code of Laws, Title 44, Chapter 53. As citizens of the state, students and college employees are responsible for knowing about and complying with public law. College orientation information for students and employees, handbook materials, the website information above, the SCC Student Code, and SCC personnel policies support state law.

Students are responsible for abiding by the Spartanburg Community College Student Code whether on or off-campus. Failure to do so can result in criminal, civil, and college disciplinary proceedings and sanctions. Student organizations that violate the law and/or the SCC Student Code are also subject to college disciplinary actions and sanctions, up to and including dissolution of the organization. Violations of the college alcohol and drug abuse policy and the SCC Student Code will be reported to SCC Campus Police and to the Dean of Student Engagement for investigation and disciplinary actions.

#### Substance Abuse Education

The college has developed a program to prevent the illicit use of drugs and the abuse of alcohol by students and employees. The program provides services related to drug use and abuse, including dissemination of informational materials, educational programs, counseling services, referrals, and college disciplinary actions. The Office of the Vice President for Student and Community Advancement provides overall coordination of the Drug-Free School Program. However, many services are the responsibility of other areas of the institution. These include:

Alcohol and Drug Education: Employee Assistance Program, Student Assistance Program, Student and Employee Orientation Activities, Student Life (workshops and seminars on topics such as alcohol-free beverages [mocktails] and drunk-driving awareness in collaboration with the S.C. Department of Transportation)

*Counseling Services:* Counselors and Employee Assistance Program Referral Services: Student Development Counselors Employee Assistance Program, Student Assistance Program, Spartanburg County Alcohol and Drug Abuse Counseling referral.

*College Disciplinary Actions*: Employee Disciplinary Action through SCC HRM; Student Disciplinary Action through SCC Student Engagement Services.

Below are local, state, and federal legal sanctions.

*Laws Governing Alcohol:* The State of South Carolina sets 21 as the minimum age to purchase or possess any alcoholic beverage. Specific ordinances regarding violations of alcohol laws, including driving while intoxicated, are available on the college's website, under Consumer Information and the Office of Student Life.

*Laws Governing Other Illegal Drugs:* Possession and distribution of drugs such as marijuana, cocaine, heroin, and crack cocaine may vary according to the circumstances under which the arrest was made and the related circumstances, such as the amount of drugs. Fines can range up to \$200,000, confinement can be up to 30 years, and driver's licenses can be suspended from six months to one year.

A violation of any law regarding alcohol and Illegal drugs Is also a violation of the college's Student Code of Conduct and will be treated as a separate disciplinary matter by the college.

#### WORKPLACE VIOLENCE

Spartanburg Community College aims to promote a safe, respectful, and productive work environment to deliver quality academic programs and public service activities. To this end, the College will not tolerate, condone, or ignore workplace violence. Each department head, manager, supervisor, and employee is responsible for keeping the workplace free of violence. This includes intimidating, hostile, threatening, or violent behavior by employees or non-employees (vendors, job applicants, visitors, spouses, etc.) against self, others, College property, or property owned by third parties but present on College premises.

Any person who experiences, observes, or has knowledge of actual or threatened workplace violence has the responsibility to report the situation immediately. In the case of an actual or imminent act or threat of violent behavior, call Campus Police 864-592-4911.

Pursuant to the South Carolina Concealed Weapons Act, other applicable State laws, and college policy, firearms are not allowed on the campus of Spartanburg Community College unless the possessor is a salaried law enforcement officer in an identifiable official uniform. Any student with a firearm in his/her vehicle is subject to applicable laws of the State of South Carolina. SC Code of Laws—Section 16-23-420; It is unlawful for a person to possess a firearm of any kind on any premises or property owned, operated, or controlled by a private or public school, college, university, technical college, other post-secondary institution or in any publicly-owned building, without the express permission of the authorities in charge of the premises or property.

The provisions of this subsection related to any premises or property owned, operated, or controlled by a private or public school, college, university, technical college, or other post-secondary institution do not apply to a person who is authorized to carry a

concealed weapon pursuant to Article 4, Chapter 31, Title 23 when the weapon remains inside an attended or locked motor vehicle and is secured in a closed glove compartment, closed console, closed trunk or in a closed container secured by an integral fastener and transported in the luggage compartment of the vehicle. Persons whose conduct violates state law will be prosecuted in the appropriate criminal court.

#### SEXUALLY ASSAULTED

On Campus Report it immediately to Campus Police at 864-5924911. Give Campus Police, as much of the following information as you can:

- Your exact location
- Your name and the phone number from which you are calling
- The severity of your injuries
- Pertinent details where it occurred, how long ago
- Information about the offender name (if known), description, direction of flight, description of vehicle (color, make, license plate number)

Do not disturb the crime scene. Taking a shower, washing, or changing clothes will destroy potential evidence. Please advise if you would like a friend or family member to be contacted. The campus will be searched immediately for suspects, outside law enforcement agencies will be contacted for assistance, and a timely search for the suspect will be communicated in the campus community and in the local tri-county area.

The alert will be initiated by whatever means necessary to communicate the pertinent information to the campus community. Spartanburg Community College, Campus Police, and any assisting law enrollment agencies will maintain the victim's name and personal information as confidential. The SCC Office of Student Engagement will investigate any report of sexual assault on campus involving a student and will be responsible for initiating disciplinary proceedings. Both the accuser and the accused are entitled to due process, and both will be notified of the outcome of any disciplinary actions. SCC procedure as it relates to alleged acts of sexual violence and sexual harassment can be found in college policy and procedure. Pursuant to the Violent Crime Control and Law Enforcement Act of 1994, information concerning registered sex offenders may be obtained on the Internet at www.sled.sc.gov.

#### HOW TO REPORT A CRIME

To report a medical, fire, or law enforcement emergency, day or night, seven days a week, call 911. The Emergency call boxes located conspicuously across the campuses can also be used for emergencies. By pressing the button on this call box, you are immediately placed in contact with the Campus Police Communications Center. Use the emergency call box to report any type of emergency, whether fire, medical, crime-in-progress or, if you simply need police assistance. Please remember it is for Emergency Use Only. Any suspicious activity or person seen in the parking lots or loitering around

vehicles or inside buildings should be reported to the SCC Police Department at 864-592-4911.

#### ENCOURAGEMENT OF ACCURATE AND PROMPT CRIME REPORTING

Spartanburg Community College members, students, faculty, staff, and guests are encouraged to report all crimes and public safety-related incidents to the SCC Police Department promptly. To report a crime or for non-emergency circumstances, call Campus Police: 4911 from campus phones or 864-592-4911 from outside the college phone system. Emergency call boxes are located conspicuously around the campus; when initiated, these call boxes will be directly dialed to Campus Police dispatch. A Dispatcher is available 24 hours a day, seven days a week, to answer your call.

In response to a call, Campus Police will take the required action, dispatching an officer and filing an incident report. Incident reports involving students who may have violated local laws, college policies, or the Student Handbook guidelines are forwarded by Campus Police to the Dean of Student Engagement for review and potential action. Campus Police will investigate a report when it is deemed appropriate. Additional information obtained via the investigation will also be forwarded to the Dean of Student Engagement.

If assistance is required from local police, Campus Police will contact the appropriate unit. If a sexual assault or rape should occur, staff on the scene, including Campus Police, will offer the victim a wide variety of services. Crimes should be reported to Campus Police to ensure inclusion in the annual crime statistics and to provide timely warning notices to the community when appropriate. Regardless of which police agency is contacted, all community members are highly encouraged to report all crimes to the appropriate police agency promptly and always remember to accurately report the crime by answering the questions: **Who, What, When, Where, and How**. When you call the police, be prepared to provide the following information:

- · Your name and telephone number,
- The type of incident or suspicious activity,
- The location of the incident of which you are reporting,
- A detailed description of the suspect(s) and his/her location or direction of travel,
- A detailed description of any vehicle involved in the incident and
- Any need for medical assistance.

#### **COUNSELORS AND CONFIDENTIAL CRIME REPORTING**

All reports will be investigated. Violations of the law and/or the Spartanburg Community College Student Code will be referred to law enforcement agencies and, when appropriate, to the Dean of Student Engagement for review and follow-up action, as appropriate. When a potentially dangerous threat to the college community arises, timely reports or warnings will be issued through email announcements, text alerts, or other appropriate means. There is no separate maintenance of confidential disclosure of campus crime statistics.

Students who report possible criminal activity or student code misconduct as a perpetrator or victim during a confidential counseling session with a Spartanburg Community College counselor are encouraged to report this activity to the Spartanburg Community College Police Department. This information is included in the statistics of the SCC Police Department or local law enforcement authorities. Students are informed as a part of confidential counseling procedures that information is subject to disclosure in cases where this information will protect individuals from imminent danger, where abuse or neglect is expected, or upon service of a court order.

#### LIMITED VOLUNTARY CONFIDENTIAL REPORTING

If you are the victim of a crime and do not want to pursue action within the college system or the criminal justice system, you may still want to consider making a confidential report. With your permission, the Campus Police officer can file a report on the details of the incident without revealing your identity. The purpose of a confidential report is to comply with your wish to keep the matter confidential while taking steps to ensure your future safety and that of others. With such information, the college can keep an accurate record of the number of incidents involving students, determine where there is a pattern of crime concerning a particular location, method, or assailant, and alert the campus community to potential danger. Reports filed in this manner are counted and disclosed in the annual crime statistics for the institution.

# **EMERGENCY RESPONSE & EVACUATION PROCEDURES:**

#### **EMERGENCY RESPONSE**

The college's Emergency Response Plans and Information Manual includes information about Emergency Response Teams, Incident Command Posts, Triggering Events, and Response Guidelines, including Shelter-In-Place and Evacuation Guidelines. The college conducts emergency response exercises yearly and tests the emergency notification systems on campus weekly. These exercises are designed to assess and evaluate the emergency plans and capabilities of the institution. Campus Police officers have received training in incident command and responding to critical incidents on campus.

When a serious incident occurs that causes an immediate threat to the campus, the first responders are usually the Campus Police. They and local authorities typically respond and work together to manage the incident. Depending on the nature of the incident, other college departments and local or federal agencies could also be involved in responding. General information about the college's emergency response and evacuation procedures is publicized annually as part of the institution's Clery Act

compliance efforts. That information is available on the college website at: <u>https://sccsc.sharepoint.com/sites/M\_Info\_Sites/campuspolice</u>.

Campus Police are responsible for responding to and summoning the necessary resources to mitigate, investigate, and document any situation that may cause a significant or dangerous emergency. In addition, Campus Police are responsible for responding to such incidents to determine if the situation threatens the community. If that is the case, Federal law requires that the institution immediately notify the campus community or the appropriate community segments that may be affected by the situation.

The SCC Police Department will be directly dispatched from the County Regional 911 Communications Centers in Spartanburg, Cherokee, and Union Counties in the event of an emergency. If Campus Police confirms an emergency or dangerous situation that poses an immediate threat to the health or safety of some or all members of the college community. In that case, the Chief of Police and the Vice President for Student and Community Advancement will collaborate to determine the content of the message. They will use some or all of the systems described below to communicate the threat. This communication may be to the entire college community when the threat is to a very large segment of the campus community or the appropriate segment of the community if the threat is limited to a particular building or segment of the population.

Continuing assessment of the situation may require additional campus community segments to be notified. The Chief of Campus Police and the Vice President for Student and Community Advancement will, without delay and considering the safety of the community, determine the content of the notification and initiate the notification system unless issuing a notification will, in the judgment of the first responders (including, but not limited to Campus Police and local authorities), compromise the efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency. In the event of a serious incident that poses an immediate threat to college community members, the college has various systems in place for communicating information quickly.

Some or all of these methods of communication may be activated in the event of an immediate threat to the college community. These methods of communication include emergency text messages (individuals can sign up for this service on the college website at <a href="https://sccsc.sharepoint.com/sites/M\_Info\_Sites/campuspolice">https://sccsc.sharepoint.com/sites/M\_Info\_Sites/campuspolice</a>, pop-ups on teacher workstations in classrooms, and emergency sirens. The college will post updates during a serious incident through one or more communication channels. Members of the larger community interested in receiving information about emergencies on campus should sign up for the emergency text message service. If a dangerous situation exists on campus, it can potentially affect the surrounding community. In that case, the Chief of Campus Police will call the appropriate local authority, depending on the nature and type of emergency, to determine to initiate its community notification process.

## **CAMPUS FACILITIES:**

#### SECURITY ACCESS

During business hours, all campus academic buildings will be secure with control access doors. Students, faculty, and staff must scan their ID access badge to enter academic buildings during business hours. Parents, guests, and invitees must report to the Campus Police Department for a "Visitor Badge" before accessing campus buildings. During non-business hours, anyone wanting to access college facilities must report to Campus Police or Campus Security to sign in before entering any campus building. Closed circuit cameras are placed throughout the campus grounds and parking lots and in the hallways of campus facilities. These cameras are monitored 24/7 through campus police dispatch.

#### MAINTENANCE OF CAMPUS FACILITIES

Facilities and landscaping are maintained in a manner that minimizes hazardous or unsafe conditions. The campus community may assist with maintenance through access to a maintenance work order system that includes repairs of security-related issues such as locks, doors, lights, and windows. In addition, groundskeepers maintain campus shrubbery in a manner that minimizes opportunities to hide. SCC Patrol Officers maintain a constant vigilance of and report any environmental issues, such as area lighting, that are inoperable through the SCC Communications Center to the appropriate SCC Operations Department.

There is a quarterly security meeting, often including representation from the Executive Team, Campus Police, Campus Operations, Human Resources, Student Engagement, Procurement, and Marketing Communications to discuss various security issues. Additionally, members of the college's Emergency Management Team meet regularly to review and discuss campus risk-management issues, campus safety, and crime prevention measures and take actions as appropriate to improve the safety and security of the campus environment, including communicating campus safety information to the college community.

#### **CLERY REPORT**

The Clery Act requires institutions to disclose crime statistics for the prior three (3) full calendar years for specific categories of crimes and offenses. The Clery Report includes statistics for the following types of crimes and offenses that appear in the Clery Report as required:

#### Glossary of Terms Used in the Annual Security Reports

**Aggravated Assault:** An unlawful attack by one person upon another to inflict severe or aggravated bodily injury. This type of assault usually includes the use of a weapon or means likely to produce death or great bodily harm. This type does not include Simple Assaults. When a gun, knife, or other weapon is involved, the crime will be classified as Aggravated Assault, even if there is no injury.

**Arson:** The willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, or personal property of another kind.

**Burglary:** The unlawful entry of a structure to commit a felony or theft. For reporting purposes, this definition includes unlawful entry with intent to commit a larceny or a felony, breaking and entering with intent to commit a larceny, housebreaking, safecracking, and all attempts to commit any of the abovementioned crimes.

**Dating violence:** Means violence by a person in a romantic or intimate relationship with the victim. Whether there was such a relationship will be gauged by its length, type, and frequency of interaction.

**Domestic violence:** Includes asserted violent misdemeanor and felony offenses committed by the victim's current or former spouse, current or former cohabitant, person similarly situated under domestic or family violence law, or anyone else protected under domestic or family violence law.

**Drug Abuse Violations:** Violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include opium or cocaine and their derivatives, marijuana, synthetic narcotics, and dangerous non-narcotic drugs.

**Hate Crimes:** The crimes noted on page 16 &17 under Hate Crimes, along with Larceny/Theft, Simple Assault, Intimidation, and damage or vandalism of victim's property or other crimes involving bodily injury in which the victim's actual or perceived race, religion, sexual orientation, gender, gender identity, disability, ethnicity, or national origin is a factor in the Clery Report according to the category of prejudice.

**Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to an actual physical attack.

**Larceny:** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

**Liquor Law Violations:** The violation of laws or ordinances prohibiting the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor,

maintaining unlawful drinking places, bootlegging, operating a still, furnishing liquor to minor or intemperate person, using a vehicle for illegal transportation of liquor, drinking on a train or public conveyance, and all attempts to commit any of those above. This term does not include drunkenness or driving under the influence.

**Motor Vehicle Theft:** The theft or attempted theft of a motor vehicle. This term includes all cases where automobiles are taken by persons not having lawful access, even though the vehicles are later abandoned - including joyriding.

**Murder/Non-Negligent Manslaughter:** The willful (non-negligent) killing of one human being by another. NOTE: This category excludes deaths caused by negligence, attempts to kill, assaults to kill, suicides, accidental deaths, and justifiable homicides.

Negligent Manslaughter: The killing of another person through gross negligence.

**Non-campus Buildings or Property:** Any building or property owned or controlled by the college, used to support the college's educational purposes, is frequently used by students and is not within the same reasonably contiguous geographic area of the college.

**On-Campus or College Property**: 1) Buildings or properties owned or controlled by the college within the same reasonably contiguous geographic area and used by the college in direct support of or a manner related to the college's education purposes, i.e., Any classroom or other building on campus. 2) Buildings or properties within or reasonably contiguous to the college, owned by the college but controlled by another person, frequently used by students, and support institutional purposes.

**Public Property:** All public property, including thoroughfares, streets, sidewalks, alleys, and parking facilities, is within or immediately adjacent and accessible to the campus.

**Robbery:** Taking or attempting to take anything from the care, custody, or control of a person or persons by force or threat of force, or violence and/or by putting the victim in fear.

#### Sex Offenses – Dating Violence, Domestic Violence, and Stalking:

- **Dating violence –** violence committed by a person:
  - (A) Who is or has been in a social relationship of a romantic or intimate nature with the victim and
  - (B) Where the existence of such a relationship shall be determined based on consideration of the following factors:
  - (C) The length of the relationship.ship.
  - (D) The type of relationship ship.
  - (E)iThe frequency of interaction between the persons involved in the relationship.

• **Domestic violence** – includes felony or misdemeanor crimes of violence committed by:

- (A) a current or former spouse of the victim
- (B) a person with whom the victim shares a child in common
- (C) a person who is cohabitating with or has cohabitated with the victim as a spouse
- (D) a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies
- (E) any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.

• **Stalking** – engaging in a course of conduct directed at a specific person that would cause a reasonable person to:

(A)fear for their safety or the safety of others or

(B)suffer substantial emotional distress.

**Sex Offenses-Forcible:** Any sexual act directed against another person, forcibly and/or against that person's will, or not forcibly or against the person's will, to which the victim cannot consent.

- **Forcible Rape:** The carnal knowledge of a person, forcibly and/or against the person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of their temporary or permanent mental or physical incapacity (or because of their youth).
- Forcible Fondling: The touching of the private body parts of another person for sexual gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of their youth or because of their temporary or permanent mental incapacity.
- **Forcible Sodomy:** Oral or anal sexual intercourse with another person, forcibly and/or against that person's will; or not forcibly against the person's will where the victim is incapable of giving consent because of their youth or because of their temporary or permanent mental or physical incapacity.
- **Sexual Assault With An Object:** The use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of their youth or because of their temporary or permanent mental or physical incapacity.

Sex Offenses-Non-forcible: Unlawful, non-forcible sexual intercourse.

- **Incest:** Non-forcible sexual intercourse between persons related to each other within the degrees wherein marriage is prohibited by law.
- **Statutory Rape:** Non-forcible sexual intercourse with a person under the statutory age of consent.

**Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Stalking:** A course of conduct directed at a specific person that would cause a reasonable person to fear for her, his, or others' safety or to suffer substantial emotional distress.

**Unfounded:** If a reported crime is investigated by law enforcement authorities and found to be false or baseless, the crime is "unfounded." Only sworn, commissioned law enforcement personnel may determine that a crime is unfounded.

**Vandalism:** To willfully or maliciously destroy, injure, disfigure, or deface any public or private property, real or personal, without the consent of the owner or person having custody or control by cutting, tearing, breaking, marking, painting, drawing, covering with filth, or any other such means as may be specified by local law.

**Weapon Law Violations:** The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; all attempts to commit any of those as mentioned above.
